Article 323-43

Pursuant to Articles L. 214-178 and L. 214-183 of the Monetary and Financial Code, the depository shall have custody of the securitisation vehicle's cash and claims and make sure that the management company's decisions regarding said securitisation vehicle comply with applicable laws and regulations.

The provisions of this section shall apply to financial instruments issued under French law or the law of another country.
