## **General regulation of the AMF**

### Article 422-189-1 into force from 22 February 2019 to 21 November 2019

### Article 422-189-1

The initial capital of a SCPI, a SEF or a GFI shall be fully subscribed and paid up by the founding members, with no "public offering". The shares shall be non-transferable for a period of three years from the date of issue of the AMF approval.
