- I. SCPI, SEF or GF) may not make any public offering unless it has:
- 1 Drafted an offering document authorised by AMF;
- 2 Issued a subscription form.
- II. Furthermore, the initial public offering shall be subject to the following:
- 1 The subscription and paying up of the original capital by the founders;
- 2 The approval of the management company;

- 3 Acceptance of the external real estate valuation expert presented or the forest appraisers presented;
- **4** Approval of the bank guarantee mentioned in Article 422-190.
