#### Article 422-203

In the event of withdrawal agreement of the SCPI, SEF or GFI's management company, the general meeting of each of the SCPI, SEF or GFIs in question shall be convened within two months in order to choose a management company which agrees to provide management for these SCPI, SEF or GFIs.
