**Are you changing your Investment Services Compliance Officer (RCSI)?
Would you like to enrol an employee for the AMF training and/or
examination to obtain the RCSI professional licence? You will find all the
information you need to report the change and about the RCSI licence here.**

You are reporting that your RCSI has changed

If you change the person responsible for compliance and internal control in your company, you must complete the appropriate form in the change to investment management company details document, which forms Annex 1 of [AMF Instruction DOC-2014-01](https://www.amf-france.org/en/regulation/policy/doc-2014-01) URL = [https://www.amf-france.org/en/regulation/policy/doc-2014-01].

This form must be sent to your usual portfolio manager. But if you don't know him already, send an email to:

- PSI@amf-france.org if you are a retail or private bank or a distributor
- intermediaires@amf-france.org if you are a market intermediary

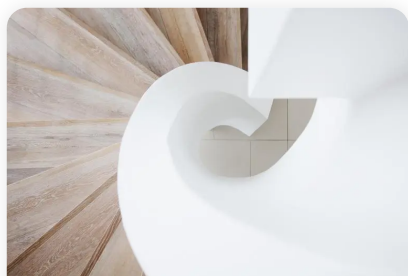
