Instruction DOC-2016-02 describes the organisational conditions that must be fulfilled by a portfolio asset management company managing AIFs wishing to grant loans. It defines the requirements for obtaining authorisation or an extension of authorisation. It also specifies the conditions for reporting to the AMF and the Banque de France for the investment management company on all loans granted by its funds. The

form detailing the quarterly declarations to be made to the AMF is provided on the ROSA extranet.
