The AMF renews its consultative commissions and the Climate and Sustainable Finance Commission

Following a call for candidates, the AMF has announced the new composition of its consultative commissions on Markets and Exchanges, Disclosures and Corporate Finance, Clearing, Custody and Securities Settlement, Asset Management and Institutional Investors and Retail Investors. The composition of the Climate and Sustainable Finance Commission (CCFD) was also renewed.

The members of the consultative commissions are appointed by the AMF Board for their expertise in the areas covered by each commission. In addition, the Retail Investors Consultative Commission is made up of representatives of retail investor advocacy associations and experts in investor advocacy and information. The term of office of consultative commission members is three years and is renewable.

When selecting candidates for this renewal, the AMF was careful to strengthen the expertise of its consultative commissions on transversal issues that are particularly important in the current context, such as sustainable finance, extra-financial reporting, cryptoassets and blockchain. Particular attention was paid to parity, which has increased by an average of 13% with this renewal. The commissions are chaired by members of the AMF board whose role is to lead the debates and draw conclusions.
