The Commission's role is to provide technical expertise and an overview of market developments and practices, as well as emerging issues. Since its creation, the Commission has, for example, worked on the extra-financial reporting of companies and the principle of double materiality, on the role of rating agencies and suppliers of environmental, social and governance (ESG) data, and on carbon neutrality. The Commission also provides advisory opinions on draft reports or doctrine documents of the Authority.
