Crypto-assets: the Autorité des Marchés Financiers warns the public about the activities of several unauthorized entities

The Autorité des Marchés Financiers has published a list of new websites offering crypto-assets or crypto-asset services illegally in France.

Since the beginning of 2026, the AMF has added 23 names to its list of unauthorized websites to offer crypto-assets or digital asset services in France.
